SECOND AMENDMENT TO THE BYLAWS OF
RAVENNA WOODS, A CONDOMINIUM

Pursuant to the authority set forth in paragraph 7 of the Condominium Declaration of Ravenna Woods, a Condominium, recorded in the records of King County, Washington, under receiving no. 8106110804, the Rules and Regulations of the Association (Schedule "A" to the Bylaws) are hereby amended as follows:

Paragraph 1. No industry, business, trade, occupation or profession of any kind (commercial, religious, educational, or otherwise designed for profit, altruism, or other) shall be conducted, maintained, or permitted on any part of the property, nor shall any "For rent", "For lease" signs or other window displays or advertising be maintained or permitted on any part of the property or in any apartment therein nor shall any apartment be used or rented for transient hotel or motel purposes.

The Board of Directors reserves the right to permit placement of one "For Sale" sign in a unit, and a "For Sale" sign underneath the Ravenna Woods address sign board on NE 89th St and on Ravenna Ave NE. The board also reserves the right to permit up to two "Open House" signs, during a realtor open house, on the grass or other areas where persons do not walk. The frequency of "Open House" sign placement shall be governed by house rules and shall be fixed initially at no more than two days per month, per unit for sale. In no event will any "For Sale" sign be larger than one foot by two feet, nor any "Open House" sign larger than two feet by two feet. The cost of the sign under the Ravenna Woods sign shall be borne by the homeowner and shall provide a method of contact designated by the homeowner.

All other provisions of the Rules and Regulations not inconsistent with the foregoing shall remain unchanged.
